

# **West Wendover Municipal Court Bail Schedule**

- While the actual fine imposed in a particular case lies within the sole discretion of the sentencing judge, the following list is typical of fine amounts imposed on misdemeanor violations in the West Wendover Municipal Court
- The number on the left is the West Wendover Municipal Code for the charge for which you are cited/arrested
- The single-digit number in parentheses after the description of the charge (moving violation) is the number of demerit points assessed by the DMV for this violation.
- The multiple digits in parentheses before the bail amount indicates the following (fine/administrative assessment/court facility fee/special court project fee)
